The **LED or INC** group covers LED fixtures and incandescent lamps. For LED fixtures, the wattage is for the fixture, not the individual LED's that comprise the fixture.

The **FL, MV or SV** group is for florescent lamps, mercury vapour lamps and sodium vapour lamps (high pressure or low pressure) and all other types, excluding LED and incandescent lamps. The wattage for the **FL, MV or SV** group is assessed on the lamp wattage, excluding the ballast. The lower wattages in the bands allow for the losses in the ballasts.

For the purpose of the Registry, the Register Content Code and Available Hours is CN12.
